

WOW TAKE A BOW BOARDING & GROOMING, LLC ("WTAB")

Agreement and Indemnification Form

Admittance to programs or facilities will not be allowed without this signed Agreement on file. This form is not modifiable.

1. Owner agrees to pay for boarding, grooming, training and any additional related expenses for services that have been requested or otherwise provided by WTAB pursuant to this Agreement and the Registration Form. Payment for estimated charges is due pursuant to the Registration Form, unless payment is in default, in which case, payment is due upon demand.
2. WTAB agrees to keep the facility clean and properly sanitized. Owner agrees that he or she has had an opportunity to examine the facilities and premises and has found them acceptable.
3. WTAB retains the right to secure veterinary care if deemed necessary by WTAB staff. WTAB will attempt to contact Owner for care authorization, however, if Owner is not readily available, he or she agrees to pay any fees associated with care deemed necessary and authorized by WTAB.
4. Owner understands that there are inherent risks associated with the presence of dogs and other animals in boarding, training, and group play facilities and agrees that all due diligence, usual care and caution have been and are being exercised by WTAB.
5. WTAB is hereby granted a lien on any dog or other animal (whether or not animal has been removed from premises) for unpaid boarding or other charges which are 30 days past due. Further, 10 days after default and written notice to owner, WTAB may re-home a dog or other animal to cover unpaid charges and expenses.
6. Owners agree that any complaint resulting from boarding or other services provided must be made in writing within seven (7) days of the animal's removal from WTAB or is hereby waived.
7. Owners hereby agree to hold harmless Wow Take a Bow, Jillian Gartner, her staff, volunteers, agents, and the owner/lessor of the facility, from any harm to or loss of their pet or harm or loss caused by their pet, including, but not limited to, any damage or injury resulting from an accident or other occurrence on the premises or its surroundings. Owners further agree to indemnify WTAB against any and all attorney fees, collection and court costs associated with enforcing or defending this Agreement.

8. Children must stay quiet at all times and may not enter the kennel, corral or play group areas for safety reasons unless formally registered in supervised WTAB children's programs. Parents remain responsible for their children's behavior and safety at all times.

9. Animal scuffles will be interrupted by staff or volunteer staff only. Owners shall not attempt to break up interactions between animals while on site.

10. Owner acknowledges and agrees that, dependant on the general health of each dog and each dog's prior exposure to other animals, even a vaccinated dog can become sick while boarding or interacting with others and that all reasonable steps have been taken by Wow Take A Bow to prevent or minimize exposure to sick animals.

11. The undersigned grants full permission to WTAB to use any photographs or videotapes of boarding, training and play group events for any purpose.

I have read and agree to the above policies, procedures and indemnifications.

I understand and agree that this form shall be signed the first time an Owner registers an animal with WTAB and shall be kept on record by WTAB as being in full force and effect with respect to all future registrations, and boarding, training and grooming agreements, oral or written, by or for the same Owners and with respect to all of their pets.

This Agreement shall be liberally construed so as to protect and indemnify WTAB, its owners, agents, insurers, and their successors and assigns.
